



The organization that Paul works with is trying to stop some of the bloodshed by standing by as witnesses and being an international presence in support of Palestinian civilians.

Point Methodist Church History

Church history is rich with contributions of women. One church group in the 1920's was the SOCIAL LEAGUE of the first Methodist Episcopal Church whose history is reflected in their minutes printed below and taken from the canvas covered, red leather cornered notebook which cost \$1.15. The minutes are printed as written This is the 57th installment.

Dec 7, 1926

Social League met at the home of Mrs. Dillen. Mrs. Oehne assisting her as hostess. Our president Mrs. Halbrook presiding. 12 members were present and 3 visitors. It was mentioned that the members had been getting thread at Mrs. Gnaga's for embroidery work for the bazaar. The Secretary was asked to inquire about the amount of the bill. Mrs. Dicely being absent and Mrs. Vlueberg (sic) gave a report on the bazaar. She reported that the bread for the luncheon had been donated by the Ward Co. and the milk had been donated by the Richmond Farm Creamery. And the report read that \$129.00 had been deposited in the bank with other money to be turned in.

The Sec. appointed to write a letter of thanks to the Ward Co & Skows Creamery for the donations. Moved and seconded that a committee of 3 be appointed at each meeting to furnish some sort of entertainment on League days. Motion carried. Mrs Jones suggested that we have a sort of a New Years Jinks on the second meeting in January. Have a luncheon & an afternoon of stunts and entertainment for the members. Motion made & carried that we carry out this suggestion. The committee to be appointed at our next meeting. Rev Grant asked if the League would work up a special program for the next community service to be held in the church, the it would be a Xmas service.

It has a documenting problem as that most of the clipped articles do not give credit to the source, most however seem to be from the "Richmond Herald-Record". I do not know who put it together. LIGHTED CIGAR STUB CAUSES FIRE ALARM

May 29, 1919

Carelessness of a roomer at 108 Washington avenue last night in throwing a cigar stub among inflammable material in the rear of the building, causing an alarm of fire to be sent in last night at 9:30 o'clock, which was immediately responded to by companies one and two.

Prompt work on the part of the firemen saved that portion of the city from a disastrous blaze, for all the buildings surrounding are wooden affairs. All the roomers in the building fled to the streets and gave the firemen ample opportunity to fight the blaze. The damage to the structure was but slight.

NEW COTTAGES FOR WESTERN END OF TOWN

April 17, 1918

The first of the Mintzer cottages which are being erected at the Point on Cottage avenue is

well under construction. There are several of these cottages to be erected and they are to be modern in every particular and built with an idea looking toward permanence and appearance. An architect and building constructor have the work in charge and they expect before the summer is over to have solved in a measure the housing problem for this city.

J.A. Rolph, one of the prominent Standard Oil employees is building a fine cottage on Montana avenue, next door to the George Lee Home. It will cost when completed in the neighborhood of \$2500.

121 August 26, 1916

The Penal code defines the meaning of "malfeasance in office," and "dereliction of duty."

It is now

121

days since affidavit was made to the District Attorney's office, in which it was asked that the red light abatement act be enforced against Grace Miller, and still nothing has been done.

In addition the disreputable readhouses along San Pablo avenue and the malodorous plase of Odom, just off Twent-third street are operating full blast. Odoms liquor license was taken away from him some time ago, but he is still selling liquor without a license, and has such a crowd of girls at his plase plying their illicit business, that it would make your head swim.

Odom and his band of "soiled doves" say business is good, and there is no pretense of secrecy about their operations.

WHY?

There is one house of ill-repute on Railroad avenue - the old row. It is owned by Helen M.

Drew, alias Rose Porter.

126 Days have passed since the cleanup campaign in this city began, when Rev. P.E. Petersen filed his affidavit against these houses with the county clerk and still the office of the district attorney has done nothing. Rose Porter is still occupying her cottage at No. 70 Railroad avenue and houses adjoining are vacant. It is presumed that the Porter woman is plying her trade. Although the district attorney has been asked to remove her, so that owners of the property adjoining can rent to reputable tenants. He has not acted.

WHY?

170 October 14, 1916

170 days have gone by since the district attorney's office should have acted in the redlight abatement cases in and about Richmond in connection with the affidavit filed by Rev. P. E. Petersen. While there is no disposition to ruch matters at all, still it might be supposed that time enough has elapsed to secure some action, especially when it is considered that several private persons throughout the county have gone before the court in similar cases and secured almost immediate results.

For instance, Attorney Alvin Gerlack, as president of the Richmond Welfare league, has succeeded in putting out of business at least three of these houses and there are others which will be taken care of in the near future. The Welfare league has made an exceptional good record for the time it has been working. Equally as good work has been accomplished by the sheriff's office in the vicinity of Pittsburg and Antioch. If the same results cannot be obtained by the district attorney's office the people all over the county are wondering WHY?

BUTCHER AUTO RUNS DOWN TELEGRAPH MESSENGER March 14, 1918

What came near being a very serious accident occurred at Richmond and Washington avenues this morning, when an automobile and a bicycle came together, resulting in the demolishment of the latter and the brusing up of A.L. Lewis, messenger of the Western Union Telegraph company.

Lewis was riding east on Richmond avenue and when he reached Washington, the delivery auto of the Reigert butcher shop crashed into him, throwing him from the wheel and mashing it up.

Lewis, picked himself up, brushed off his clothes, and took a car back to his office, seemingly none the worse for the accident.

It is stated that the burcher's auto was getting up speed in order to make the Washington avenue grade.

LADY BUGS HERE IN LARGE NUMBERS May 31, 1919

An invasion of Richmond was made today by swarms of lady bugs. They came to town this forenoon by the millions, and seemed to like the place, for they are making no effort to pass of.

The lady bugs were imported to California thirty years ago by the horticulturists from Australia for the purpose of destroying green aphis, and it is said they are serving the purpose excellently. Just what they are doing here, however, it is somewhat of a problem, but they are here just the same, and will remain until they get ready to leave.

Allan's Point

August 14, 2002 passed and I did not give it a thought nor did the media mention that August 14, 1945 was the date that Japan surrendered ending World War Two in the Pacific. I was on an ammunition ship at that time and we had just left the Panama Canal to join a convoy when we got the news of the surrender. The Captain kept the ship blacked out for several days in case some of the enemy ships did not receive the news. Three years, eight months and 22 days after Japan bombed Pearl Harbor, World War Two ended. September 2nd is known as V-J Day (Victory over Japan).

On August 20, I saw a group of men and boys entering 113 Park Place. That is the location of the Park Place Barbershop, owned by John Veirs, an El Cerrito native, but he has spent so much of his time in the Point that we can call him an Honorary Point Richmond Native. John and his partner, Gene, had just returned from a two week vacation and the shop was closed during that time. Talk about a bunch of long-haired customers and with no place to sit. Gene has just completed 30 years at the ship along with John who has 40 years to his credit.

Speaking of barbershops, why did Hydrangea



Flowers, the very successful Point Florist, obliterate the antique "Barbershop" and "O. Shimade, Shoemaker" signs that were painted on the top side of their shop on 145 E. Richmond Avenue, which was the former Dornan Building. It was discovered when the building was being remodeled. There went early 1910 Point Richmond History. I wonder who the barber was and I do remember the shoemaker, I think. Point native Theresa (Bernardi) Meninghelli (see page 1), said she went to school with the daughter of the shoe maker Shimada. I took a photo of the building before the signs were stuccoed.

The story of early school days in Richmond is very interesting and I would like to copy from an essay titled, "The Story of Richmond, California" by Lee D. Fridell. It was copyrighted in 1954 and was the property from the estate of the late Ethyl Kerns, the loving librarian of the former main Richmond Library located on Fourth Street and Barrett. That library was a Carnegie donation and is not the home of the Richmond Museum of History.

SCHOOL DAYS

The story of early school days in Richmond centers around a young lady named Emily Miss Boorman had received her Boorman. diploma as a member of the first class graduated from San Francisco State College. It was a bright July morning in 1901 when she began here teaching career. Perhaps the warm sunshine should have brightened her spirits. Instead she felt hollow in the stomach as she walked toward the Methodist Church at Point Richmond. There was nothing like starting your teaching career at the bottom--a church basement to be exact. If anyone had told her two months earlier that her first job would be to teach eighty-seven children in a church basement, she would never have believed



them.

An added note: just four months previously, in Richards Hall, Richmond's first school with fifteen students was opened with Mr. O'Dell as teacher. Richards Hall must have been a popular place. That was where the first Mass was said by Our Lady of Mercy Catholic Church in 1902. By the way, who was 'Richard'.

I have given to the PRHA a graduation booklet of the June 1922 High Eighth Class of Washington School. It is affectionately called "The Poppy" because at that time the entire Point hills were covered with the state flower. Here is a photo of that entire class. Please check out the perfect penmanship used for the program as well as my 'Perfect Penmanship Certificate'. I received these historical items from Ila May Dein (McGarvey) - related to Howard Arnold.

It's a small world: I was at Kaiser Hospital in San Rafael when a young nurse noticed in my record that I was from Richmond. She asked me if I knew anyone from the Point (That was like asking me if I ever heard of Babe Ruth!) It turned out that Michelle, the nurse, is the granddaughter of the late Clara and Charlie Perasso. Her mother is the Perraso's daughter, Barbara. Who can forget the beautiful blond Clara and Charlie?

Charlie started to work for the Whitesides Grocery, now known as the Santa Fe Market. My mother used to send me to the store to buy a watermelon and she always said to be sure to have Charlie plug it. That was the method grocery stores offered customers to test the melon for color and ripeness before purchasing. Hey, Bob Peckham, "plug" me a watermelon! Michelle gave me the phone number and address of her uncle "Bobby" Perasso. Bobby grew up with us here in the Point, still lives in Richmond and was a great friend of my late brother, Leonard.

The first railroad train arrived in Richmond at noon July 3, 1900. Captain Lauritzen took passengers to San Francisco on the S/S Ocean Wave - the first and largest ferry. Ferry Point must have been built by then.

I checked out Starbucks. The coffee I had was served in paper cups, not my style and of course, the half and half container was empty. The music played fits the years of the young employees who, by the way were very nice. I like my ww2 music. While there, I sat with Jean Eger, Point Richmond's talented artist. She was preparing for the school opening. I asked about her son, Bill. Well our former paperboy is now a Captain in the U.S. Navy stationed in Monterey. Jean will donate some prints for our church's BBQ and raffle in October.

Why isn't there night school classes in the Point? We have all the facilities?

The late Richard Malloy, Point native, used to keep me informed about what is happening in the Point. The truck drivers that are customers of the place sure settle on the roadway. Turning right at the lights you have to go to the opposite lane to continue, as their trucks block the lane.

What about all the empty office buildings on Garrard Blvd? What's happening?

The season used to start in May and finish in August. The games were played every Tuesday and Thursday nights of each week - 30 games in all. We all remember the First Street Baseball Park - it was where the St. James Apartments and the Richmond Rescue Mission now exist.



June 4, 2002



I have been a Pt. Richmond resident for eight years. I read with interest your open letter to the BNSF Railway in the Summer 2002 issue. Hopefully your points will be noticed and taken up by them.

On your point of abandoning the crossing, you might have taken a step too many. A discussion with a friend that worked at Santa Fe for 30 years tells me that the line is an important track to work the west end of the yard. The tracks father out in Shoreline park are used as storage, and could possibly be abandoned.

Also, if the track were to be abandoned, there would be no need for a crossing, nor the wig wags. They would not be functional. I believe that is a major part of their value and charm.

Finally, I would like to point out a problem created by crossing gates. The gates across Cutting Blvd. are often activated as the train switches the auto delivery center off of Canal

Blvd. The train does not cross Cutting, but will push back into the auto center. Cars sit waiting for a train that never comes. If gates were to be installed at W. Richmond, we would have the same problem. The trains often pull down to were they activate the wig wags, but instead push back into the yard and never cross the street.


